## WAIT LIST OPENING FOR MAINSTREAM PREFERENCES THIS IS NOT FOR THE GENERAL SECTION 8 VOUCHER WAIT LIST

The Housing Authority of the County of Alameda (HACA) will open its Section 8 Housing Choice Voucher wait list to referrals of individuals or families that contain a non-elderly (age 18 to 61) person with a disability who is homeless, at risk of becoming homeless, or at serious risk of institutionalization for the following limited preferences:

Non-Elderly Disabled Individuals and/or Families who are at Serious Risk of Institutionalization <u>Referred</u> by the Non- Elderly Disabled (NED) Program Lead Organization or Alameda County Care Connect or its Equivalent in Other Jurisdictions	20

<u>Please note that Application Packages will only be accepted from referral agencies as</u> <u>specified above.</u> <u>NO</u> applications will be taken from the general public at this time.

Please also note that <u>only</u> the "Maximum Number of Applications that will be Accepted" listed above that qualify for the listed preferences and have submitted a complete Application Package will be placed on our Section 8 Wait List.

Eligible applicants' portion of the rent is based on household income and ranges from 30% to 40% of the family's adjusted monthly income. HACA pays the rest of the rent directly to the landlord, up to a maximum. HACA serves all of Alameda County except the cities of Alameda, Berkeley, Livermore and Oakland. With some restrictions, Section 8 housing assistance lets you live in a unit and city of your choice.

**How to Apply:** Application Packages will be available to referral agencies as specified above beginning December 21, 2018. To request an Application Package, referral agencies should email <u>hacai@haca.net</u> or call (510) 727-8512. Application Packages will be accepted <u>only from the organizations described above</u> from January 7, 2019 at 12:01 a.m. through January 10, 2019 at 11:59 p.m. or when 90 applications as specified above are received, whichever occurs first. Application Packages must be complete including

requested verifications and must be submitted with a signed Mainstream Wait List Referral and Certification Form from the referring agency submitting the application. Incomplete applications will not be accepted. The 90 complete applications will be added to the wait list in order of random selection and a receipt mailed to the applicant within 10 business days of making the determination. Claimed preferences will be applied and ties will be broken by the application's random selection order. If an application is denied placement on the wait list, the applicant will be notified within 10 business days of making the determination. The notice will specify the reasons for ineligibility and will inform the applicant of its right to request an informal review.

Qualifications to Apply: All applicant households must meet the following criteria:

- 1. At least one household member must be between the ages of 18 and 61 <u>and</u> be a person with a disability; and
- 2. Be referred by a homeless service organization, Non-Elderly Disabled (NED) program Lead Organization, one of HACA's Mainstream Voucher Program Partners, or Alameda County Care Connect or its equivalent in other jurisdictions; and
- 3. At least one household member must be a U.S. citizen, eligible immigrant or Violence Against Women Act (VAWA) petitioner; and
- 4. No household member can be subject to a lifetime registration requirement under any of the 50 states' sex offender registration program; and
- 5. No household member can have been convicted of drug-related criminal activity for the production or manufacture of methamphetamine on the premises of federally-assisted housing; and
- 6. The total income (including wages, Social Security benefits, pensions, child support, unemployment benefits, CalWin (TANF), General Assistance, net income from a business, etc.) of all the persons listed on the application must not exceed the following:

**Note:** No applicant has the right or entitlement to be listed on the wait list, or to any particular position on the wait list. Placement on the wait list does not indicate that the family is, in fact, eligible for assistance. A final determination of eligibility will be made when the family is selected from the wait list.
